# Criteria for Membership



## Executive Women's Partnership

A Greater Houston Partnership Business Resource Group

Please check the category that applies.

### Chief Executive Officer

Chief Executive Officer (CEO) is defined to be the top executive officer. Other titles equivalent to CEO may include Chairman, President, Managing Partner or Managing Director.

This individual

1. must be a current or past Board Member of the Greater Houston Partnership, or
2. must be the CEO of a Greater Houston Partnership member company with at least \$10 million in annual revenue and at least 50 employees.

### Corporate Executive

This individual

1. must be within two executive levels of the CEO of a Greater Houston Partnership member company or subsidiary with annual revenue of \$500 million or more, or
2. must be within one level of the CEO of a Greater Houston Partnership member company or subsidiary with at least \$100 million in annual revenue.

Additionally, this individual

1. must have either profit and loss responsibility, corporate budget or policy-making responsibility, and
2. must be an executive officer.

### Women Owned Business

This individual

1. must be the CEO of a Greater Houston Partnership member company, and
2. must have at least \$10 million in annual revenue and at least 20 full-time employees.

### Professional

This individual

1. must be an equity shareholder or partner of a Greater Houston Partnership member company with at least \$20 million in annual revenue and at least 50 employees, and fulfill one of the following criteria:
  - a) serve on a management committee of the Greater Houston Partnership member company responsible for national or Houston office-wide leadership activities, or
  - b) chair a practice area or business unit for the entire Greater Houston Partnership member company with a minimum of 10 or more professionals, or
  - c) chair a practice area or business unit for the Houston office that is composed of 15 or more professionals.

### Not for Profit

This individual

1. must be the CEO or within one executive level of the CEO of a Greater Houston Partnership member company, and
2. must have at least \$10 million in annual revenue and at least 50 full-time employees.

### Corporate Board Member

This individual

1. must be a current Board of Director for a company listed on a major stock exchange, or
2. must be a current Board of Director of a private company with at least \$500 million in annual revenue.

### Physician

This individual

1. must be the Chief Medical Officer of a large healthcare system, or
2. Department Chairperson or Clinical Chief of a large medical school department or
3. On an exception basis:
  - a) Division or Section Head in a large hospital with notable (nationally recognized) contributions in her field or a well-recognized, highly-accomplished member of the Houston community, and
  - b) must be recommended for membership by at least two current, active members of EWP who will each write a letter of recommendation on the applicant's behalf.
